# Hoofbeats . . . .

*News from the Clubhouse by Marty Clegg, Secy/Treas*

After an absence of meetings in March and April due to COVID-19, the regular May monthly meeting of the Falls City Mustang Club met at the home of Steve and Nancy Merritt on 20 May 2020. Steve welcomed everyone to the meeting under these unusual circumstances. Marty Clegg, Sec/Treasurer, reported on the club finances along with distributing copies of the treasurer's report to everyone. Steve reported that the New Albany American Legion intends to reopen in June and that would allow the FCMC to resume holding the meeting there. Steve met with Chris O'Neal this past week regarding the status of the annual June car show. Mr. O'Neal felt it would be best to cancel the car show in light of the COVID-19 situation and state guidelines. Steve added that to hold the car show at an alternate site would be difficult, especially getting sponsors onboard along with all the other logistics needed to host a successful car show. Steve asked for member's thoughts on this cancellation and the members present all agreed to cancel the car show this year. Steve and Nancy do plan to host a pony trail and cookout on June 20; details will be sent to everyone in the near future. Steve asked if anyone knew of any car shows in the area during May and June as it appears most or all have been cancelled. Marty reported that the FCMC had received monetary sponsorships from three companies for the June car show. He is planning to contact the companies to discuss how to handle the monetary donation, possibly rolling it over to the 2021 June show or returning the money to the company. Steve and Marty discussed how to deal with future club donations in light of cancelling the car show. The fourth quarter donation will be lowered to \$300 and a donation of \$100 worth of donuts will be purchased and donated to each the Floyd Baptist Hospital in New Albany, the Clark Memorial Hospital in Jeffersonville and the U of L Hospital in Louisville to honor the first line health care staffs. Annual donations such as the Cops for Kids, Crusade for Children and others will probably be at a lower monetary amount. Steve reported that the annual FCMC Christmas party is planned for the clubhouse at Garry and Pam Bushau's neighborhood. The food will need to be catered for the event. The annual breakfast and poker run hosted by Brenda and Marty Clegg has been moved to September 12. Steve encouraged everyone to show up at the Sellersburg McDonald's for the June 19 monthly cruise-in. Whether the FCMC will be permitted to host a cruise-in is uncertain at this time, we can at least make an attempt at it! Well, no one had their favorite number drawn for the cash drawing, so it will again roll over to \$100 for the June meeting. Dining prior to the June meeting will be at El Nopal off of Grant Line Rd in New Albany. Being no further business, the meeting was adjourned.
